RESOLUTION NO. 2024-06

A RESOLUTION OF THE BOROUGH COUNCIL OF FELTON BOROUGH, YORK COUNTY, PENNSYLVANIA, RE-ENACTING, AND RE-IMPOSING FOR THE FISCAL YEAR 2025, THE GENERAL TAX RATE OF 2025, ESTABLISHED IN ORDINANCE 2022-02, AND RE-ENACTING AND RE-IMPOSING THE REALTY TRANSFER TAX

WHEREAS, Felton Borough Council adopted Ordinance 2022-02 imposing a tax for general purposes for the fiscal year 2023 at the Three (3) Mills on assessed valuation taxable real estate within Felton Borough; and

WHEREAS, Borough Council desires to re-enact and re-impose the real estate tax rate established in Ordinance 2022-02 for the fiscal year 2025; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of Felton as follows:

SECTION 1: Property Tax. The tax rate for the fiscal year beginning January 1, 2025, and ending December 31, 2025, is hereby established at Three (3) Mills on assessed valuation of taxable real estate situate within the Borough of Felton, York County, Pennsylvania, for general Borough purposes.

SECTION 2: Discount / Penalty. A rebate or discount of Two (2%) percent shall be allowed if the tax levied in Section 1 above is paid on or before April 15, 2025, and a penalty of Ten (10%) percent shall be added to the tax if paid after June 15, 2025.


SECTION 3: Realty Transfer Tax. Pursuant to the provisions of the Local Tax Enabling Act, Act No. 511 of 1956, P.L. 1257, as amended the realty transfer tax previously levied or enacted is hereby levied and re-enacted and continued without change for the fiscal year beginning January 1, 2024, at the rate of one-half (1/2) of one (1%) percent, originally imposed by Ordinance enacted December 9, 1964, and re-enacted pursuant to 72 P.S., Section 8101-D, et seq. by Ordinance No. 1987-02, enacted October 5, 1987.

SECTION 4: Repealer. All provisions of any previous Ordinance or Resolution inconsistent with the provisions of Resolution are hereby repealed.


